 4 and ORDERS the following deadlines¹:



16 Settlement Website, Volume Adjustment 17 Protocol Website, Toll-Free Number go live, 18 informational press release distributed on PR 19 Newswire, (the “Initial Outreach Notice 20 Date”)	No later than August 18, 2025
21 Digital Notice to begin running, sponsored 22 search listings acquired, and Direct Mail 23 Outreach to begin	As soon as practicable after Initial Outreach Date, but no later than October 16, 2025
24 Plaintiffs’ Motion, Memorandum of Law and 25 Other Materials in Support of their	No later than December 19, 2025

 28 does not approve of these dates by July 28, 2025, then the deadlines listed need to be
 adjusted accordingly by the number of dates after July 28, 2025, the Joint Stipulation
 is approved.
